

30 MINUTE TOWING ROADSIDE ASSISTANCE – COMMERCIAL/SERVICE/RENTAL/FLEET ASSURANCE PLAN TERMS & CONDITIONS

You, the benefitting recipient of the Roadside Assistance Assurance Plan, agree to the following terms & conditions:

1. You Acknowledge This Plan is a Contractual Agreement for Roadside Assistance coverage.
2. Types of Vehicles Eligible: All Passenger Vehicles, Sprinter & Cargo Vans, Light & Medium Duty Service Vehicles.
3. You Are Eligible to Receive up to [3] of any of the following services, valid for up to **1 Year** after Policy Effective Date.
4. **SERVICES COVERED**
 - a. GAS/FUEL DELIVERY (2-3 gallons)
 - b. BATTERY JUMPSTARTS
 - c. TIRE SERVICE (WITH SPARE)
 - i. TIRE CHANGE (WITH SPARE)
 - ii. TIRE CHANGE (NO SPARE)
 1. You must pay the cost of either the new spare or the replacement tire and labor costs for plan to be eligible.
 2. Does not include tire cost or tire shop charges.
 - d. TOWING (up to 10 miles)
5. You agree not to hold 30 Minute Towing, Alliance Business Group, or any affiliated organizations to the aforementioned liable for any claims regarding property damage, miscellaneous cost, injury, theft, death or any other liability for the entirety of this contract agreement.
6. In the event we do not have an in-network service provider in the area of the Roadside Assistance scene, we will find an out-of-network provider to provide the service, with any additional cost being upheld by us, except for any pre or post mentioned clauses.
7. You agree that your Policy is not in Effective Status until Dues (below) are either paid in full, or payment installments are current and up to date.

REQUIREMENTS FOR ELIGIBILITY OF COVERAGE:

1. All Vehicles must have a minimum of [1] functional spare tire in cargo at all times.
 - a. 10% Discount if [2] Spare Tires are kept in cargo at all times.
 2. All vehicles maintenance must be up-to-date.
3. All Rental customers must sign a Waiver (will be provided if necessary), agreeing not to hold 30 Minute Towing, Alliance Business Group Inc, or any affiliated organizations liable for any claims regarding property damage, miscellaneous cost, injury, theft, death, or any other liability in perpetuity.

COVERAGE OPTIONS

 - Base Price = \$379/Year per vehicle or (\$34.72 Monthly)
 - Covers the [Continental] UNITED STATES (not including Alaska/Hawaii/Puerto Rico or any of the offshore territories)

 - Base Price = \$299/Year per vehicle or (\$28.92 Monthly)
 - Covers your entire State of vehicle address
- **LOCAL**
 - Base Price = \$199/ Year per vehicle or (\$19.60 Monthly)
 - Covers 100 Square Miles from your vehicle address
